OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. A VALID EMAIL ADDRESS IS REQUIRED.

- 1. ELIGIBILITY:** The Respawn® Gum National Gaming Sweepstakes (the "Sweepstakes") is offered only to legal residents of the 50 United States and the District of Columbia, who are 18 years of age or older at the time of entry. Void where prohibited or restricted by law. Employees, officers and directors, of Mars Wrigley Confectionery US, LLC ("Sponsor"), TPG Rewards ("Administrator"), Inc., their respective owners, parents, subsidiaries and affiliates, advertising and promotion agencies, and any companies involved in the implementation and execution of the Sweepstakes (collectively, the "Sweepstakes Entities") and their immediate family members (spouses, siblings, parents, and children, including foster and step-relations, and their respective spouses) and household members (whether or not related) are not eligible. the program microsite. Click on the link to access the microsite, where you must go through the regular registration process, including playing the game and completing the entry form with the required information, to receive one (1) entry into the Sweepstakes. No matter the results of the game-play, you will earn one (1) entry after completing the registration process. Standard message and data rates may apply. Proof of text message submission is not considered proof of delivery to or receipt by Sponsor of such entry. **There is a limit of one (1) entry per person per day, regardless of entry method.**
